Registration Requirements

1. Competitors must Pre-enter classes ONLINE @ www.striderpro.com
2. Then search for KDCTA shows OR find direct link on our website www.kdcta.org OR use the bit.ly link above.
3. Copy of coggins, signed EWaiver for all riders are required. A second waiver will be signed at CTP Equestrian. Any required documents can be uploaded to your Strider account, then can be attached to the show you wish to attend.
4. STRIDER's open-access entry platform supports guest checkout and payment with any credit card, VENMO or PayPal through a secure payment gateway. You can even upload coggins and when completing entries as a guest.
5. NOTE: Your credit card statement will show entry fees and STRIDER handling fee as separate charges.
6. ***To save time as a frequent STRIDER user, you can create a FREE member account. Benefits include:
 - Cloud-based document storage (save your coggins, equine vaccine records, and more)
 - Convenient horse & rider profiles for expedited entries (add multiple horses/ riders in one member dashboard)

7. PAYMENTS: All payments are taken through StriderPro.com. Use a Credit card, VENMO or PayPal. <https://bit.ly/KDCTAEventRegistration>
8. **CLOSING DATE:** Saturday September 19, 2026 at 12am.

This Show is held over TWO DAYS. Dressage will be held at the Grange Fairgrounds on Sept 26th. Cross Country and Stadium Jumping will be held at CTP Equestrian on Sept 27th. Riders may choose to do all 3 phases or just one or two.

General Rules For Both Days

1. Registration Booth opens at 8:00AM. All Rings/Courses start at 9:00 AM unless otherwise stated.
2. The decisions of the judges and show secretary/manager are final. USEF/USDF/USEA rules will be followed.
3. The show management reserves the right to cancel, combine, add or divide classes if conditions warrant.
4. AGE: As of January 1st Jr Riders = 18 years & under, Sr. Riders = 19 years and up.
5. DRESS: Dress will be casual, but suitable boots and an ASTM certified helmet are required for every rider while mounted anywhere on show grounds. Pinneys are required.
6. Safety Vests are REQUIRED for cross county jumping.
7. ALL DOGS must be leashed at all times.
8. Entries received after the closing date will be charged a late fee (\$20) and will be considered only if spots available. Contact the Show Secretary.
9. REFUNDS & CLASS CANCELLATIONS: In the case where a horse has been entered and not shown in a Dressage class or CT class, fees will be forfeited. Refunds will only be made with a vet certificate or if canceled prior to closing date minus \$20 office fee. Refunds will be made within 7 days after the show.
10. COGGINS: A copy of a negative Coggins taken within 12 months of the show date is required for each horse entered. If no proof of Coggins, you will be asked to leave the show grounds.
11. Ride times will be posted on the KDCTA.org website and emailed 48 hours before the show.
12. *****All Competitors need to check out at the registration office before leaving the show grounds.*****

1. **GROUND'S FEE:** per horse/rider combo on the grounds.

Dressage, Cross Country, Stadium: \$115

Work out of Trailer Day Fee: \$30

Sat. Stall Fees: \$45 per day for horse/tack stall.

One stall on: Sat only=\$45, Fri/Sat=\$90, Sat/Sun=\$90, Fri-Sun=\$135

Shavings: \$8.50 per bale of shavings

2. **CAMPING/RV's at Grange:** \$50 per night. Includes electric and water hook-ups and one free dump at the Dump Station. 30- and 50-amp service is available.

Saturday Grange Stabling and Parking

1. **ARRIVAL:** No arrivals before 4pm on Friday. Any horses arriving on Friday cannot be ridden or worked anywhere on the grounds. Hand walking on the roadway is permissible. Use of any rings or arenas on Friday is strictly prohibited. Only use stalls assigned to competitor. Use of additional stalls or shavings must be approved by show management. Warm up on Sat and Sun in specified rings only.
2. **STABLING:** Stalls & Shavings must be requested on pre-registration entry form. No straw bedding allowed. Stalls do not need to be cleaned prior to departure. No nails or staples or fans are allowed. No cooking or sleeping in the barns is allowed. Additional shavings must be requested from the show manager or stall manager. Please include stabling requests in notes to the organizer when registering.
3. **PARKING:** Trailer parking only in designated areas. No trailers next to the barn except for unloading/loading. **No parking any trailers or loading/unloading horses on the grass camping area.**
3. **CAMPING/RV's:** Must provide vehicle and license plate info upon arrival. \$50 per night. Includes electric and water hook-ups and one free dump at the Dump Station. 30- and 50-amp service is available.

Sunday CTP Parking

1. Enter through the gate and stay to the right to go up to the parking lot. Follow directional signs and any outgoing trailers need to look for incoming trailers as it is a single lane from the road until you get to the gate.

Awards

1. **DRESSAGE:** All dressage tests will be placed according to eventing rules. Tests can be picked up in the office on Saturday. Ribbons will be presented on Sunday at CTP Equestrian.
2. No ribbons will be given for schooling rounds.

KDCTA Schooling Horse Trial- Levels Defined

The September 26th/27th, 2026 schooling horse trials hosted by KDCTA and CTP Equestrian is aimed to provide a fun, relaxed format three-phase event at an introductory level. The mission is to provide the opportunity to give eventing a try, even for riders and horses brand new to the sport. As such, the jumping at all levels will remain very introductory to each level. Most jumps will be below maximum height, set up in a positive and simplistic way. Our hope is to attract riders out there who have wanted to give eventing a try, and are looking to do so in a low-key, inviting way. Dressage will be held on Saturday September 26th at the Grange Fair Grounds. Showjumping and cross-country will be held on Sunday September 27th at CTP Equestrian.

Introductory Level- Fences not to exceed 2'.

Dressage: Riders will ride USDF Intro Test C and will adhere to USDF Guidelines for Dressage.

Stadium Jumping: The course will be inviting and straightforward, not exceed 8 fences and be composed of cross rails and verticals. The course will be lines of no less than 82' per USEA recommendations, or single fences, no combinations.

Cross-Country: Fences will be natural- type obstacles such as logs and coops, with clear ground lines where warranted. The course will not exceed 10 fences. No water, ditches or banks will be required. The layout and terrain will be inviting for riders and horses new to the sport, with gentle hills and no turns smaller than 20m radius.

Starter Level- Fences not to exceed 2'3".

Dressage: Riders will ride USEA Starter Test A and adhere to USEA Guidelines for Dressage.

Stadium Jumping: The course will be inviting and straightforward in design, not to exceed 8 fences and will be composed of verticals and oxers. Lines will be no less than 82' per USEA recommendations, or single fences, no combinations.

Cross-Country: Fences will be natural-type obstacles such as logs and coops, with clear ground lines where warranted. The course will not exceed 12 fences. Water and ditch will have options and no fences related to them. There will not be a bank jump. The layout and terrain will be uncomplicated with gentle hills and no turns smaller than 20m radius.
